# **Updates from around the Gadbrook Park estate**

#### **Junction improvement**

Scottish Power were on-site in January and now Cheshire West and Chester Council are working on the new lane. We are hopeful that this work will be completed by the end of March. Further to this, the BID team has been assured that there will be no disruptions to the flow of traffic while this work is being carried out.

#### Injunction

Our solicitors have now received the sealed Order from the Court following our application for alternative service being approved. As we have now complied with all of the requirements under the Order, the next step will be for them to file a Certificate of Service with the Court to confirm that we have met our obligations.

Once 'Persons Unknown' have had the requisite time to acknowledge the proceedings (and provided this deadline has passed without hearing anything from them), the next step will be to make an Application for Default Judgement against them. With the expectation that this will be granted by the Court in the absence of any engagement from Persons Unknown, this should then provide us with a final Order confirming the Injunction which will prevent Persons Unknown from entering the Business Park.

This means that should they trespass onto the Business Park in the future, the Police will have greater powers to remove them. Our solicitors have a direct link to the local Police force and they are aware of the current application and therefore once they have this final Order, they will ensure that this is provided to them along with Cheshire West and Chester Council so they are fully informed and can notify Persons Unknown of the Injunction. This should mean that they are able to appropriately plan their future responses in the event of a further trespass.

Springboard Cheshire provides free one-to-one personalised support from expert employment advisors to unemployed people so they can quickly start their new career. Advisors work with participants to build their confidence and skills so they can apply for jobs as well as providing practical support and training on elements such as CV development, interview techniques and digital skills.
