This meeting gave the board the opportunity to discuss crime, ASB, encampments and other relevant issues. There was a subsequent meeting with Inspector Murray and Chief Inspector Moss by the BID manager to follow up the issues discussed with the board.

The Chair and the BID Manager also met local MP, the Rt Hon Esther McVey, to put forward the businesses' fears when an encampment enters the park.

HS2

The proposed route of HS2 Phase 2b passes through the area of Wimboldsley to the east of Winsford, Davenham, Rudheath and Lostock Gralam. A depot will be constructed close to Wimboldsley to accommodate up to 54 high speed trains. The HS2 Supplementary Environmental Statement and Environmental Statement for the area between Wimboldsley and Lostock Gralam states that the current indicative construction programme is between 2027 and 2033.
